Enrollment

Before you can begin LUMRYZ, your doctor's office will start the process to enroll you in:

1 RYZUP™ SUPPORT SERVICES

Enrolling into RYZUP Support Services allows your NCN to help you navigate the insurance process and help connect you with financial assistance, if you qualify. To enroll in RYZUP Support Services, you are required to sign a Patient Authorization Form.

2 LUMRYZ REMS

Enrollment in LUMRYZ REMS is required for you to receive LUMRYZ. As part of the REMS enrollment process, you are required to sign the LUMRYZ REMS Patient Enrollment Form.



If you signed both of these forms in the office, you're all set! If not, you may receive two (2) separate emails with instructions for how to complete and e-sign.



If you're not sure if you've signed, or have questions about your enrollment status, contact your NCN.

Financial Assistance

Your RYZUP NCN will help you navigate the insurance process and help connect you with financial assistance, if you qualify.

CO-PAY ASSISTANCE

Your co-pay could be as little as \$0 if you have commercial insurance.*

TEMPORARY ASSISTANCE PROGRAM (TAP)

If there is a delay in insurance coverage, you may be eligible for up to 120 days of free LUMRYZ.†

PATIENT ASSISTANCE PROGRAM (PAP)

Treatment is available free of charge to eligible patients who are uninsured or underinsured.‡

Receiving your first LUMRYZ shipment



Once your prescription is processed, your **specialty pharmacy will call you to schedule the delivery** of your first shipment of LUMRYZ. Your prescription will be filled by 1 of these 4 specialty pharmacies: Optum Frontier, Accredo, CVS, or AssistRx.



The specialty pharmacy filling your prescription is required to speak with you live to schedule your first shipment. Be sure to follow up promptly if you miss a call from them. You can also opt-in for refill reminders to help as you begin your LUMRYZ treatment plan.

Support for when you're ready to start taking LUMRYZ

When you're ready to start taking LUMRYZ, your **NCN** will call you to review how to take the medication and answer questions you may have.
